A Letter from the Chairman of the Board and the President and CEO

Friends of Health Choice Network:

In *Our Defining Year* of 2006, we laid the cornerstone for a new Health Choice Network – a community health care organization few of us would even have recognized only a few years ago.

This year, we have been busily putting our plans into action: building a stronger, more dynamic Network with the abilities to offer more services, to reach more people in need of care and to ultimately make a greater impact on the level of community health than we ever have before.

We want to take this opportunity to provide an update on our new programs and services, to introduce our new members, outline future paths for our organization and review milestone events:

- In November, our Jessie Trice Cancer Prevention Project (JTCPP) was a partner in a remarkable research breakthrough regarding the effectiveness of spiral CT scanning to screen high-risk patients for lung cancer. The results were published in the *New England Journal of Medicine*.
- We continue to play a leading role in the creation of Regional Health Information Organizations, thereby improving the quality of community health for thousands of patients.
- We will soon launch our Provider Service Network (PSN) Prestige Health Choice, a separate organization owned by our community health members.
- School Health Connect in Our Schools celebrated its first successful year and now encompasses 72 Miami-Dade public schools and reaches out to more than 80,000 students.
- We continue to lead the way toward a paperless medical world as we promote the integration of electronic medical and dental health records across the nation.
- With the addition of new member centers in Florida and Kansas, the number of patients served by Network members now exceeds a half-million for the first time.

We eagerly look forward to the challenges and opportunities of our 14th year. With the guidance of our member CEOs, the talent of our dedicated staff and the support of our many friends and partners, Health Choice Network will continue to fulfill its mission to community health.

A Proud History of Service to Community Health

n 1994, a group of Federally-Qualified Health Centers (FQHCs) joined hands to create a network that would provide the advantages and expertise of a large health system while each member could remain independent. This unique and powerful alliance, now held up as a national model, is called Health Choice Network. The founding members recognized the common bonds community health centers share and unified those functions, giving members the highest level of professionalism and expertise. Betsey K. Cooke was named the Network's founding CEO.

Today, HCN is addressing health care disparities, providing health information technologies and strengthening the financial position of the community health care system. As a 501(c)3 organization, HCN is governed by its members who comprise the Board of Directors. Network members maintain their vital community orientation by retaining their local-governing, consumer-majority Boards of Directors. CHCs that own and control the Network operate more efficiently, can deliver care more effectively and are working together to care for more patients. Milestone events include:

- The Network formed a management services organization called Atlantic Care in 1997 to allow the Network to share in risks and rewards.
- In 1998, the Network took advantage of members' partnerships with faith-based institutions and created Healthy Body, Healthy Soul to further develop community outreach, health education and disease prevention programs.
- The Jessie Trice Cancer Prevention Project was founded in 1999. It seeks to improve cancer screening, treatment and research in underserved communities.
- By 2000, Health Choice Network was receiving national recognition for its innovations and successes, particularly in the area of information technology integration.

- In 2002, community health centers from as far away as New Mexico and Utah and as close as Broward County and Miami Beach joined the Network.
- HCN received a \$4 million grant in 2003 to integrate electronic health records in all its Florida centers.

As HCN evolves and grows, it remains bound to its goals of improving access to quality health care and reducing disparities in minority and underserved communities. The reach of Health Choice Network has spanned languages, cultures, races and geography to link a vast array of health care communities into one powerful force.

Jessie Trice Program Plays Role in Cancer Breakthrough

HCN's Jessie Trice Cancer Prevention Program (JTCPP) is a partner in a remarkable research breakthrough regarding the effectiveness of spiral CT scanning to screen highrisk patients for lung cancer. The results of a study coordinated by the International Early Lung Cancer Action Program (I-ELCAP) and published in the New England Journal of Medicine outlined the success of early detection through CT scans - a procedure that greatly increased the survivability rate for lung cancer patients.

The JTCPP established a prescreening community outreach program in which thousands of minority and underserved patients participated. The Miami team was led by Cornell University Medical School, Jackson Memorial Health System and the University of Miami. The results of the program were featured on NBC Nightly News.

HCN's Provider Service Network Prestige Health Choice Poised for Launch

After years of planning and preparation, Health Choice Network is ready to launch a unique new provider service network called Prestige Health Choice, LLC. Prestige is unique because it will be owned and controlled by community health centers with deep roots in the neighborhoods they will serve. It will provide Florida Medicaid patients with high quality, easily accessible health care services. Prestige provides patients with a powerful health



care partnership that includes physicians, hospitals and health centers. This comprehensive team is poised to become the dependable and long-sought medical home for the underserved of our region.

Health Connect In Our Schools Reaches Out to Thousands of Children



Health Connect in Our Schools is now in its second successful year of providing health services to more than 80,000 students in Miami-Dade Public Schools. Health Choice Network and five of its member health centers are providing the much-needed care in 72 schools. For many underserved children, the teams of health specialists rotating among the schools may be their only contact with a nurse or health care professional. The member centers provid-



ing care are Community Health of South Florida, Citrus Health Network, Helen B. Bentley Family Health Center, Institute For Child and Family Health and Economic Opportunity Family Health Center. The program is supported through the Children's Trust.

HCN Partners With Regional Health Information Networks

Health Choice Network continues to play a leading role in the creation of Regional Health Information Networks. By establishing and maintaining a cost-effective, secure and user-friendly health information infrastructure, patients, providers and payers can all access the same health care records. Such a system will allow efficient and effective medical care that reduces errors and delays. One example is the South Florida Health Information Initiative (SFHII). Health



New Horizons Community Mental Health Center Luvernice Croskey, Ph.D., CEO




Patients served by HCN member centers in 2006*




Patients served by Florida member centers in 2006
